
The Challenge

United Way Space Coast is a long-standing organization with a big mission—but prior to partnering with The Charity CFO, its financial operations hadn't kept pace with its impact.

When Emily returned to the organization in 2023, she faced the daunting task of modernizing operations that had become deeply underinvested.

"We hadn't had consistent monthly financials in nearly 8 years," she explained. "We had audits and quarterly reports, but the systems behind them were outdated, disjointed, and built around individual staff habits—not scalable processes."

Longtime finance staff had retired, and newer hires often left before gaining enough experience to fully understand the organization's complex financial model.



"It takes about three full (annual) cycles to truly get grounded in our structure," Emily said. "And we just weren't getting there."

The stakes were high: donor dollars needed to be stewarded responsibly, financial decisions had to be data-driven, and the board was eager for more timely, transparent insights.

The Solution



The Charity CFO stepped in with the systems, staffing, and strategy to rebuild financial clarity—without requiring a costly full-time hire.

Consistent, accurate monthly financials

"For the first time in years, we're getting reliable monthly reports by the 15th," said Emily. "They're in every board packet now. Our board is thrilled."
